Please find attached the EVERGENT Investments Assets and Liabilities Statement as of May 2021, in compliance with FSA Regulation 9/2014 - Annex 16 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main evolutions by asset categories (in RON):

- listed shares: + 11.0 million
- non-UCITS listed shares: 1.6 million
- corporate bonds: + 0.1 million
- fund units: + 1.8 million
- monetary instruments: + 59.8 million

The main asset classes in the total value of the assets under management: listed shares including the non-UCITS listed shares 68.9%, unlisted shares 8.7%, fund units 13.3%, monetary instruments 7.5%.

The net result, in the amount of RON 75.9 million, consists of RON 26.7 million net profit and RON 49.2 million net gain on the sale of assets reflected in the retained earnings - accounting treatment in accordance with IFRS 9.
