We report the following data for the end of March 2021:

• Net result: 31.5 million lei

• Assets under management: 2.259 billion lei

• EVER share price: 1.4250 lei

• Net asset value per share: 2.1730 lei

Please find attached the EVERGENT Investments Assets and Liabilities Statement as of March 2021, in compliance with FSA Regulation 9/2014 - Annex 16 - along with a brief analysis of the main variations registered in the value and structure of the assets under management.

Main evolutions by asset categories:

- listed shares: + 112.6 million lei;
- non-UCITS listed shares: + 0.5 million lei;
- corporate bonds: + 0.2 million lei;
- fund units: + 7.9 million lei;
- monetary instruments: 18.6 million lei.

The weight of the main categories of assets in the total value of the assets under management: listed shares including the non-UCITS listed shares 70.3%, unlisted shares 9.1%, fund units 13.9%, monetary instruments 5.2%.

The net result, in the amount of 31.5 million lei, consists of 19.3 million lei net profit and 12.2 million lei net gain from the sale of assets reflected in the retained earnings - accounting treatment in accordance with IFRS 9.
